- 10-year residence permit in Hungary (European Union).

- Visa-free travel in the European Union (Schengen).

- No language skills required.
- Tax liability only arises on effective residency, in this case for worldwide income. Personal income tax: 15%.
- Fast processing time of 60-90 days.
- The last Golden Visa program attracted 7 300 investors who invested over EUR 2 billion. The funds were repaid.

INVESTMENT OPPORTUNITIES

- You must hold your investment for at least five years. If you sell after that, your residence permit will still remain valid until the end of the tenth year. In the case of a donation, there is no possibility to sell.
- To be able to extend for another 10 years, you must be invested at the time of the extension. Our tip: do not sell until shortly after the extension, i.e. in the 11th year.
- The real estate funds are independent of Bentley Golden Visa and are supervised by the Hungarian National Bank.

- Bentley Golden Visa co-operates only with fund managers with a strong track record. Currently, only one is approved for Golden Visas.

01	Due Diligence call	We get to know each other in a short conversation.
02	Agreement with Bentley Golden Visa	Digitally signed on our secure platform.
03	Payment of 60% of fees	Can also be paid by a company (in this case no VAT applies).
04	Document collection for visa and securities account opening	This is the main task. Your cooperation is required.
05	Submission of visa application at local consulate	You have to attend the visit in person, as biometric data will be collected. No family members at this stage.
06	Interview at the consulate	The consul may conduct an interview with the investor.
07	Granting the guest investor visa	Investor visa will be affixed to your passport.
08	Investment in Hungary	You have 90 days to carry out the investment. We support you.



09	Investment / donation confirmation	Given by the real estate fund or, in case of a donation, by the university.
10	Application for residence permits	Bentley Golden Visa applies for residence permits (whole family)
11	Family members' visit to consulate	Family members obtain travel visas to be able to travel to Hungary.
12	Trip to Hungary	Investor and family members visit the immigration authority in Budapest.
13	Issuance of residence permits	Documents posted to Bentley Golden Visa
14	Payment of 40% of fees	Can also be paid by a company (in this case no VAT applies)
15	Shipment of your residence permits	Bentley Golden Visa sends you the document via courier

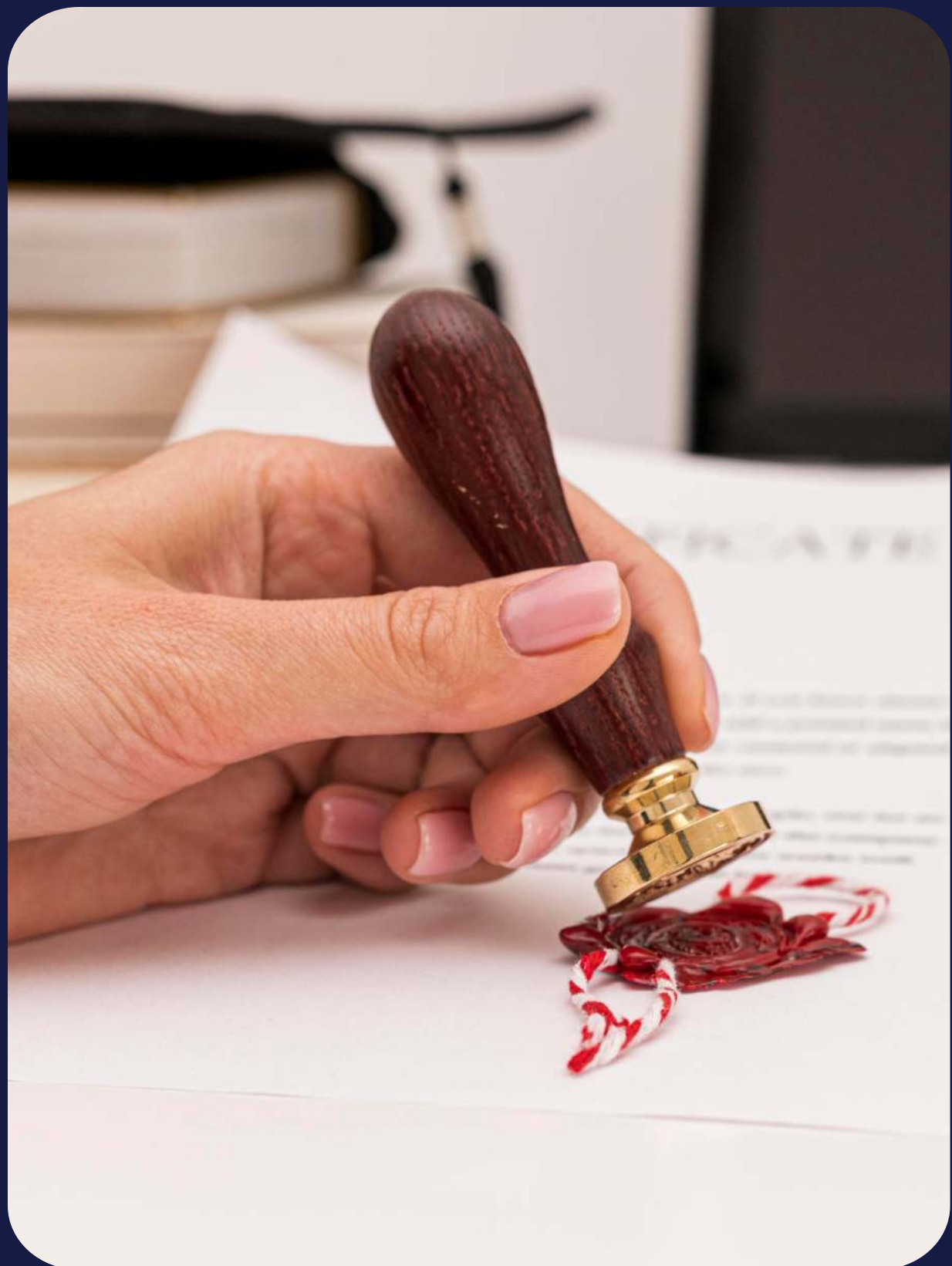


HOW LONG ARE YOU WAITING FOR YOUR GOLDEN VISA?

The total duration of the procedure can be very short and depends greatly on how quickly you can compile the necessary documents.

We need reliable evidence that you have the investment amount permanently at your disposal, that it comes from legal sources and that you have a regular income with which you can support your family.

We will provide you with precise information on how to achieve this.



HOW LONG ARE YOU WAITING FOR YOUR GOLDEN VISA?

After submitting the above and other documents prepared by us, you will receive an investor visa. The statutory processing time for this is 21 days.

You then make your investment. You can do this in one week. To do this, the investor has to travel to Hungary once.

We will then apply for a residence permit for you and your family members. In the case of the latter, we must provide proof of the family relationship with extracts from the birth and marriage registers. The statutory processing time for the residence permit is also 21 days.

So if we all hurry, you can have your residence permit in your hands in 3 months.

DOCUMENTS YOU WILL NEED

We actively support you in the procurement of all documents.

- Passports for whole family
- Evidence that you have the investment amount permanently at your disposal.
- Evidence that it comes from legal sources
- Evidence that you have a regular income with which you can support your family.
- Birth- and marriage certificates of family members.
